

## Consent to Electronic Document Delivery

1. The name of the person or entity that is the registered owner of Verva shares;
2. Contact name (if not the same as 1.); and
3. Holding Statement number

By subscribing to Verva electronic communications you agree that we may provide you with any and all Verva communications in electronic format and that **we may discontinue sending paper communications to you**, unless and until you withdraw your consent as detailed below.

1. Verva electronic communications include, but are not limited to: shareholder newsletters; annual reports; notices of annual or extraordinary general meetings; and all other Company communications for which a paper copy is not mandated by law.
  - a. Once you have subscribed, we will not send you a paper copy of any communication unless you request it or we otherwise deem it appropriate to do so.
  - b. We reserve the right, but assume no obligation, to provide a paper (instead of electronic) copy of any communication that you have authorised us to provide electronically.
2. All communications that we provide to you in electronic form will be provided:
  - a. via e-mail; or
  - b. by access to a web site that we will designate in an e-mail notice we send to you at the time the information is available; or
  - c. by requesting you download a Portable Document Format (**PDF**) file containing the communication.
3. In order to participate in Verva's electronic communications program you must have an e-mail account and web browser with an internet service provider; and software that enables you to view files in the PDF format (e.g. Adobe® Reader®).
4. You may **withdraw** your consent to receive communications in electronic form and reinstate paper communications by:
